Las Vegas, NV – July 29, 2003 – York Entertainment and KM Digital Media have agreed to a partnership that has KM providing DVD replication and VHS duplication services to Sherman Oaks, California-based York Entertainment for the next two years. KM's flexibility and their keen attention to detail are elements that we regard highly in suppliers. This partnership is a natural fit, and I anticipate a long term, mutually beneficial relationship between our organizations."
